- 1. First 4- week payment and Set up fee is required for sign up and is NON-REFUNDABLE OR NON-TRANSFERABLE.
- 2. Membership commences on the date of payment and amount will be charged every 4 weeks unless otherwise noted.
- 3. Memberships paid are non -refundable in part or full after auto-draft has gone through under any circumstances.
- 4. A physical credit or debit card must be used for the first payment to set up the Auto pay.
- 5. Fit Lab Rockport is in no way, under any circumstances, responsible or obligated to pay for member's insufficient fund penalties, returned checks, and/or over the limit fees.

- 6. Members may freeze Membership for <u>up to 7 days</u>. Member must email/write a written request 30 days in advance which will be subject to approval from Fit Lab Rockport management. **info@fitlabrockport**
- 7. Memberships paid every 4 weeks will renew automatically every 4 weeks. For cancellations, holds, and/or changes to Memberships for any reason, member must notify Fit Lab Rockport management in email or written letter at least 30 days prior to next auto-draft. Fit Lab will send a confirmation via email after the changes have been made to the account. Member agrees that Fit Lab could take up to 48 hours to respond.
- 8. All termination requests will begin <u>5 days from an email/ written notice</u> and cannot be made within the first 4 weeks of membership. All scheduled charges during those 4 weeks will process.
- 9. Once member has submitted e-mail request or written notice for any changes to membership, it is member's responsibility to ensure that Fit Lab Rockport has responded back to confirm processing the request. Fit Lab Rockport is in no way, under any circumstances, responsible for member's negligence in checking their own bank statements to ensure that membership changes, holds, or cancellations have been processed correctly. In the event of miscommunication member is responsible to produce a copy of their request and response from Fit Lab Rockport for review.
